# Friends and Fans of the "Tiger Band" at Walt Disney World in Orlando, FL

Performance in the Magic Kingdom, March 15<sup>th</sup>, 2010

To take advantage of the group rate for the Disney Tickets and Rooms, a deposit must be made. We will only be able to purchase tickets for "Friends and Fans" up to a 1:1 ratio of the Tiger Band **Performers** in the park. We will purchase tickets for "Friends and Fans" on first come, first serve order **by deposit** until the 1:1 ratio of the performers is met. We expect to have around 80 to 90 performers which will allow us to have 65 to 75 tickets available for "Friends and Fans" after we purchase them for chaperones and directors. **Everything is subject to availability.**

- The cut-off date for all "Friends and Fans" order **deposits** is: **Sept. 1st, 2009**
- The **final payment** date for all "Friends and Fans" orders is: **Dec. 1st, 2009**
- Deposit = 25% of your Grand Total

Any "Friends and Fans" that wish to stay on Disney property can do so. If we have 10 or more requests for rooms on Disney property, we can offer the group rate that is quoted on the other side of this form. The Disney property we book will be whatever All-Star Resort that is available at the time of booking. If we do not have enough to qualify for the group rate, you will need to set up your Disney property stay directly thru Disney @ (407) 939-6244. If you plan on flying to Orlando, I would suggest staying on property since the difference in the price of the room would be comparable to the rental car you would need if staying off property. If you stay on property, Disney provides transportation to and from the airport and to all of their attractions and resorts.

**You must make all of your transportation arrangements separate from the band.** Tickets will be mailed to us and delivered to you before our departure. We will only be able to make refunds based on Disney's and Best Western's refund policies (see below).

- Refunds on all Tickets and Meal Coupons: 100% refund available on all unused tickets and coupons, up to one week after our return (partially used tickets will not qualify for refund – Example: if you only use 1 day of a 4 day park hopping ticket, you will not get a refund for the remaining 3 days)
- Disney Resort Property: All cancellations less than 60 days from stay will result in a 90% forfeiture of total room cost
- Best Western Hotel: All cancellations less than 24 hours from stay will result in the forfeiture of the cost 1 night's room

We hope to have a good following of "Friends and Fans" as we travel to perform in the Magic Kingdom of Disney World in Orlando, Florida.
